



EXPORTS AND IMPORTS OF THE MINERAL SECTOR*





BRAZILIAN TRADE BALANCE






FOREIGN TRADE - MAIN PRODUCTS OF THE BRAZILIAN MINING SECTOR 2013 (%)



GDP OF THE BRAZILIAN MINERAL SECTOR






GDP METALLURGY AND NON-METALS



MINING SECTOR IN THE BRAZILIAN GDP (%)





DIRECT EMPLOYMENT IN THE MINERAL SECTOR














*CFEM 2013 / STATE (%)



Mineral Sector - Foreign trade performance 2013

In 2013 the Brazilian trade balance recorded a surplus of US\$ 2.6 billion. The exports reached US\$ 242.2 billion and the imports US\$ 239.6 billion. The external trade that encompasses mining (extractive industry, except oil and gas) and mineral transformation (metallic, non-metallic and inorganic chemical compounds) closed 2013 with a positive balance of US\$ 27.4 equivalent to US\$ 56.9 billion of exports and US\$ 29.5 billion of imports. The participation of the mineral sector in the Brazilian exports was 23.5% (iron ore alone was 13.4% of the total Brazilian exports).

Mining (extractive, except oil and gas)

The mining exports totaled US\$ 36.9 billion showing an increase of 5.7% from 2012 to 2013. This can be assigned to the increase of iron ore prices (pellets included) from US\$ 95/t to US\$ 99/t although these numbers are still lower than the average market prices in 2011 that reached US\$ 136.7/t. The iron ore accounted for 88% of the total exports of the mining sector and 57% of the exports of the mineral sector. The imports of the mining sector totaled US\$ 8.4 billion shrinking 7% when compared to 2012, mainly due to decrease of prices of the main mineral products imported by Brazil (potassium, metallurgical coal and phosphate rock).
